- b. No officer may be eligible to serve more than two consecutive terms in the same office.
- c. A person who has served in an office for more than one half of a full term shall be deemed to have served a full term in such office; and
- d. No member shall serve as a council president while serving as a local unit president.
- e. Be natural person who is 18 years of age or older. Georgia Code for Non-Profits 14-3-802
